If you would like to pay by the term, please ensure each term is paid in full by the above due dates.

DETAILS OF ANNUAL FEES

The Tuition Fee covers tuition and curriculum related costs including classroom materials and resources, subject levies, compulsory excursions and activities and school sport.

The Resource Levy covers items such as the school diary, textbooks and learning resources through the College library.

The ICT Levy covers items such as a laptop provided by the College, accessories, software, technical support and insurance.

The Activity Charge covers mandatory College camps and retreats, pastoral support activities including year level activities and transport for local excursions and College sport.

The following are excluded from the College tuition fee: instrumental/vocal tuition and hire (external tutors); representative teams' costs; replacements for textbooks, ID cards, school diaries; computer repair costs (outside of insured events); courses through external providers such as TAFE.

FINANCIAL DIFFICULTY

If you are experiencing financial difficulties, it is important to keep the lines of communication open with the College. If you are concerned about your ability to meet your financial commitment to the school, you must contact the Principal or Business Manager **before** the term's due date for payment to discuss the matter. Failure to pay on time or contact the school before the due date may lead to debt recovery action. All costs associated with debt recovery action will be on-charged to you.

ENROLMENT CANCELLATION

It is a condition of enrolment that a minimum of one terms' notice is provided for enrolment cancellations. Failure to provide this minimum notice will result in one term's fees being billed to you.
